

**T.C.G.L.S.L. Board Meeting
October 18,2010**

Karen Jones (Chairperson) called the meeting to order @ 9:00am.

Roll Call: All board officers were present. There were 12 team managers and reps. present, and one (1) Del Web Red (Jim Mcfarlane) absent. There were (8) eight guess present.

Marilyn Pelis (Holiday Travel) made the motion to accept the September minutes as written second by Diane Setler. **MOTION CARRIED.**
Sec./Treasurer (Shirley Brodie) gave the treasurer's report; As of September 30,2010 there is a balance of \$357.31 in the T.C.G.L.S.L. account.

OLD BUS: Rosters: All teams have turned in their rosters for the 2010/2011 season subject to changes.

Player's Wavier Release Form: Patty Gualandi (Spanish Village) presented the board with a copy of the form that should be used by all players. After further discussion, Patty Gualandi made the motion that the T.C.G.L.S.L. should submit this Medical Wavier Release of Liability for all team player's to signed, to be able to play in the T.C.G.L.S.L., second by Marlene Schultz (Spruce Creek South). **Motion Carried Unanimously**

Patty Gualandi also suggested that all managers should have all players fill out a Medical Information form and the managers should have a copy of this form with them at all the games.

Official Equipment: Karen Jones (Chairperson) in formed all team managers the Worth Green Dot is the only ball that can be used this year and all bats must be ASA approved. No fast pitch bats are allowed.

Karen Jones (Chairperson) ask that all managers please make sure that all umpires are informed of the T.C.G.L.S.L. rules and give them a copy of the Deference's of the TCGLSL and Sun-N-Fun Rules.

NEW BUS: Nancy Roeser (Stone Crest) questioned the time changes of some of the games on the schedule. Karen explained to her that some of the teams can not get their fields at 2:00pm and all managers were asked if they could possibly change the game times or switch which field they would play on.
