

Tri-County Golden Ladies Softball League (TCGLSL)

Meeting held at Pennbrooke, Monday, February 8, 2010

Meeting was called to order by Chairperson Karen Jones at 9:00a.m.

Officers present: Chairperson Karen Jones, Vice Chairperson Judy Jahnke and Secretary/Treasurer Shirley Brodie.

Teams represented: Holiday Travel, Del Web white, Del Web Blue, Spanish Village, Spruce Creek South, Water Oaks, Plantation and Villages.

George Hayes (PL) made the motion to accept the minutes as written seconded by Patti Gualandi (SV). MOTION CARRIED

Marlene Schultz (SPS) made the motion to accept the Treasure's report as read seconded by Patty Gualandi (SV). MOTION CARRIED

Sec. Shirley Brodie collected the \$50.00 tournament fee from all the teams and turned it over to Patty Gualandi of Spanish Village who will be the hosting team for the 2010 Tournament.

Tournament Structure: There was some discussion on whether to have one (1) or two (2) divisions this year for tournament. Ruth Adams (Del Web) made the motion to keep it at one (1) division for the 2010 tournament, second by Madge Popovich (Village). Vote was taken. 4 votes for, and 4 votes against. Chairperson Karen Jones cast the tie-breaking vote. Which made the vote 5 to 4.

Patty Gualandi (SV) informed the board that she and her committees have already started the planning for the TCGLSL 2010 Tournament. She will give us a final report at the March meeting.

There was some concern voiced about some of the players on the two Del Web teams. Karen reminded the league that Paula Inglee is a regular player on the DW White team. Ruth Adams reaffirmed that the subs on each team (White Team: Lofland, Jones, Crader; Blue Team: Schmucker, Hayman, Bublenick) are used only when there are less than 11 regular players available for a game and that the 6 subs would not be playing in the tournament.

Tournament: March 8, 2010 through March 12, 2010 with March 13, 2010 as a rain date if needed. All games will be 7 innings except for the championship game, which will be 8 innings. Game times are as follow: 9:00a.m, 10:30a.m. 12:00 noon, and 1:30 p.m.

Out Side Player and Grandfathering: The committee presented the board with a draft of their proposed changes. After further discussion it was decided to table until the next meeting to give the committee sometime to redefine their proposal. Marlene Schultz asks that if anyone had any suggestions to please e-mail them to her.

Courtesy Runner: Chairperson Karen Jones reiterated the 3.0 Courtesy Runner, 3.2 Courtesy Runner rule from home, and asked that all team managers please follow this rule.

Make-up Games: All games must be made-up if it will affect the standings for tournaments. It was also mentioned that the make-up should be figured into

the regular season. This was tabled for more discussion at the March meeting.

Chairperson Karen Jones clarified a problem about bats being marked by a person. This is a Sun-N-Fun rule not the TCGLSL.

Election of Officers: Please let Karen Jones know if you are interested in running before the next meeting. All nominations should be in at the March meeting.

Karen Jones asked everyone if they know of any teams that might be interested in joining our league to invite them to the March meeting.

George Hayes (PL) thanked the board officers for the great job they have done this year. All teams agreed and said thank you. George also suggested that we take a look at not playing games if the temperature is not above 50, or consider moving the time back later in the day if possible. This was tabled for the next meeting.
